To The Honorable, The City Council:

I am hereby requesting the transfer of \$69,467.98 from the Grant Fund's Salary and Wages Account into the Public Investment Fund's Extraordinary Expenditures Account of the Department of Human Services from Massachusetts Department of Education. The Center for Families receives a grant from the Massachusetts Department of Education in the amount of \$149,980.00. A portion of these funds is allocated for the salaries and wages for the Family Services Coordinator, English as a Second Language Teachers, Home Visitors and Home Visits. The total allocation, however, was not expended. The Department of Education has approved the transfer of the unexpended funds to cover renovation costs for the North Cambridge Center for Families.
