BOSTON, May 7, 1959

Petition of Cambridge Gas Company under section 14 of Chapter 164 for authorization by the Department of Public Utilities to issue evidences of indebtedness payable in periods of more than one year after the date thereof, but not later than September 30, 1961, in amounts not exceeding in the aggregate \$3,000,000 to bear interest at a rate equivalent to 1/2 of 1% over the prime rate at the date of issue thereof, and to apply the proceeds in part to pay outstanding bank loans and to finance temporarily a portion of the Company's construction requirements for the years 1951 - 1962 inclusive; and to borrow as required from time to time from its Plant Replacement Fund additional amounts not exceeding, together with any previous borrowings outstanding, the aggregate amount of \$2,400,000 to be used for the purpose of financing in part extensions, additions and improvements to its plant and properties.

Upon the foregoing petition the Department of Public Utilities will hold a public hearing at its hearing room, 166 State House, Boston, on Tuesday the 26th day of May, 1959 at 10:00 o'clock in the fore-noon.

And the petitioner is required to give notice of said hearing by publication hereof once at least 14 days prior to said date in the Boston Globe and Boston Herald

by registered mail to serve a copy hereof at least 14 days prior to said date on Mayor and City Clerk of Cambridge and Somerville

and to make return of service and publication at the time of hearing.


