In Board of Aldermen, Dec 27. 1882.

~~Ordered~~ Resolved,

That the public necessity and convenience require a modification of the line of Henry street, at a point near Sidney street, to wit: by taking for this purpose a certain parcel of land on the northeasterly side of said Henry street, and by ceding a portion of the land on the southwesterly side of the same, as shown by certain blue lines drawn upon the city plan of said street, now before this board.

It is therefore

Ordered,

That so much of the land on the northeasterly side of Henry street, near Sidney street, as lies between the blue and red lines as shown upon the city plan of said street, dated April 19. 1882, and now before this board, be taken for public use and laid out as a public way and a part of said Henry street. Also, that so much of the land on the southwesterly side of said Henry street, as lies between the blue and red lines, shown upon the city plan aforesaid, be ceded to the abutters upon said southwesterly side, and that the line of said Henry street be and hereby is established as the point hereinbefore named, in accordance with the blue lines marked upon the city plan aforesaid.

It is further

Ordered,

That no compensation be allowed for the land so taken as aforesaid, the land ceded by the city constituting an offset for the same, and the city having received a guaranty that no claim for such compensation shall be made.
