ORDERED:

That, in accordance with the provisions of an ordinance relative to placing and maintaining signs, the Commissioner of Public Works be and hereby is authorized to grant a permit to Arthur G. DiMeo for the erection of a canopy at 237 Massachusetts Avenue, Cambridge.

Provided that, before erecting the above named canopy, the petitioner shall obtain a permit from the Building Department and file with the City Clerk a satisfactory bond in the sum of Four Thousand Dollars (\$4,000) conditioned to save harmless the City of Cambridge from all claims for damages arising from the construction, maintenance and use of said canopy.

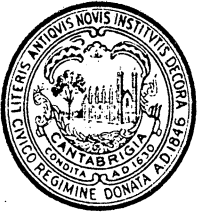

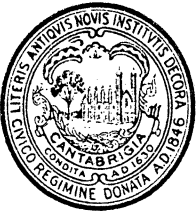

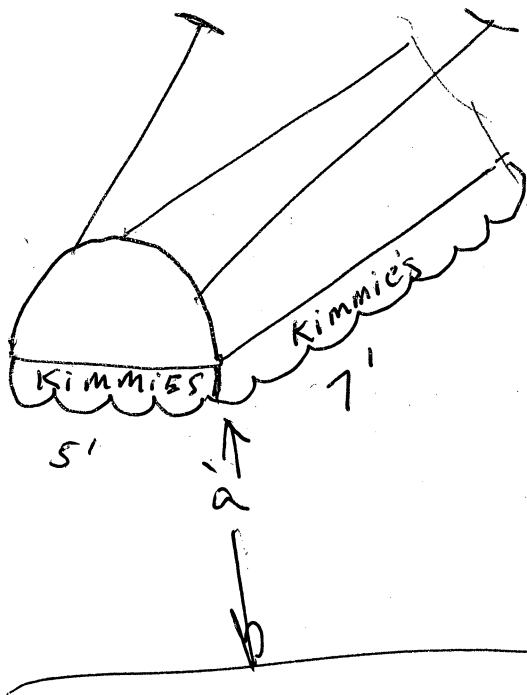
