

CITY OF CAMBRIDGE.

IN BOARD OF ALDERMEN, August 31, 1870.

The foregoing Ordinances are amended as follows:—

In chapter 2d, section 2d, on page 9, by striking out the word “Ordinance,” and inserting the word “Chapter.”

In chapter 10th, on page 26th, by striking out the 8th section, and inserting the following:—

“SECTION 8. No person under twenty-one years of age, and no person who is not a legal voter in the City of Cambridge, shall be appointed an officer or member of the Fire Department.”

In the same chapter, section 9th, on page 26th, by striking out the words “and one Driver,” in the last line on that page.

In the same chapter, section 26th, on page 31st, by striking out, in the first and second lines of the section, the words “dismissed or;” and by altering the last clause of that section, so as to read “and no member shall be reinstated, except on nomination by the Mayor, and by a vote of three fourths of the Board of Aldermen.”

In the same chapter, section 43d, by altering the pay of Engineers to \$90 per month, and the pay of Drivers to \$75 per month.

In the same chapter, section 45th, on page 35th, by altering the second and third clauses of said section so as to read—“and shall have power to appoint a suitable person to assist in the management of the Fire Alarm Telegraph, and to discharge him; the compensation of such person to be the same as that of a Driver of a Steamer Company.”

In the same chapter by striking out sections 46th and 47th.

In the same chapter by numbering section 48th on page 36th, as section 46th, and section 49th as section 47th.

In the same chapter by numbering section 50th on page 37th, as section 48th, and by altering the same to read as follows:— “Whoever violates any provision of the preceding section, shall forfeit and pay a fine of not less than five dollars, nor more than twenty dollars for each offence.”

In chapter 14th, on page 45th, by adding, at the end of said chapter, a new section as follows:—

SECT. 2. Every wagon, cart, sleigh, sled, or other vehicle used in the collection of junk, old metals, rags, or second-hand articles, shall be licensed by the Mayor and Aldermen, and shall have the owner's name and the number of the license placed upon the outside, and upon each side thereof, — in plain legible words and figures of not less than one and one-half inches in size, and so that the same may be distinctly seen. The person in whose name a license is taken out for any such vehicle, shall be considered the owner of the same until such license is surrendered, and shall be liable to the penalty prescribed for a breach of the ordinances of the city, in case of the violation of the provisions of this section.

In chapter 19th, on page 52d, by striking out the words “from and after the first Monday in January, 1870;” by altering the salary of the Mayor to three thousand dollars; and by striking out the words “and Collector,” after the words “City Treasurer.”

On page 53d by altering the salary of the City Engineer to twenty-five hundred dollars; by striking out the words “Superintendent of Schools, two thousand five hundred dollars;” by altering the salary of the Superintendent of Streets to two thousand dollars; by altering the salary of the Chief Engineer to six hundred dollars; and by altering the salary of the Sealer of Weights and Measures to five hundred dollars.

By adding at the end of said chapter 19th, on page 53d, the words “The above mentioned salaries shall be paid from and after the first Monday in January, 1870, with the exception of the salary of the Mayor, which shall remain at the sum of fifteen hundred dollar until the first Monday in January, 1871.”

In chapter 23d, section 3d, on page 58th, by striking out in the tenth line of said section the words "within one year from the date of the bond."

In chapter 25th, section 25th, on page 68th, by striking out the word "thereon" and inserting the words "upon such footway or sidewalk."

In the same section, on page 69th by striking out the words "or Superintendent of Streets," in the first line on that page.

In chapter 26th, section 3d, on page 71st, by striking out the word "Collector" and inserting the word "Treasurer."

In the same chapter, section 5th, by striking out the word "Assessors" at the end of said section and inserting the word "them."

In the same chapter in the 7th, 8th, 9th, and 10th sections, on page 72d, by striking out the words "and Collector," wherever they occur.

In chapter 27th, section 1st, on page 73d, by striking out the words "Taxes and of" in the second line of said section.

In the same chapter, section 2d, by striking out the word "Solicitor" and inserting the word "Clerk."

In chapter 29th, section 23d, on page 85th, under the title "BOARDING-HOUSES," by adding before the last line the words and figures "Each slop-closet, \$4.00."

In the same chapter and section, on page 86th, under the title "STORES, ETC.," by adding before the last two lines, the words and figures "Each slop-closet, \$1.50."

As amended, passed to be enrolled and sent down for concurrence.
