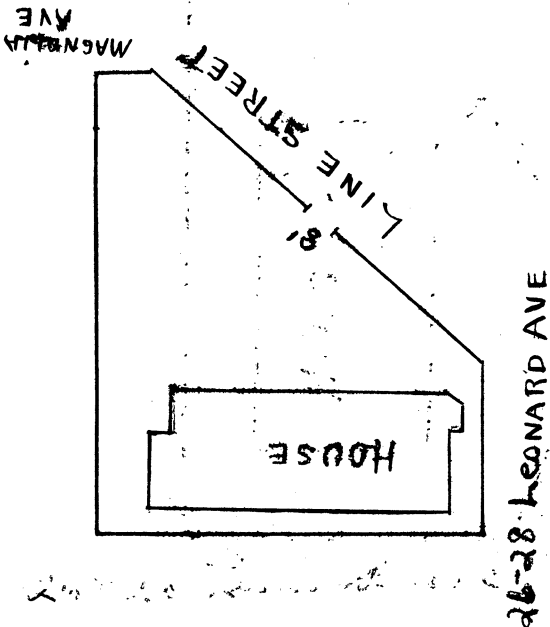
To the Honorable, the City Council of the

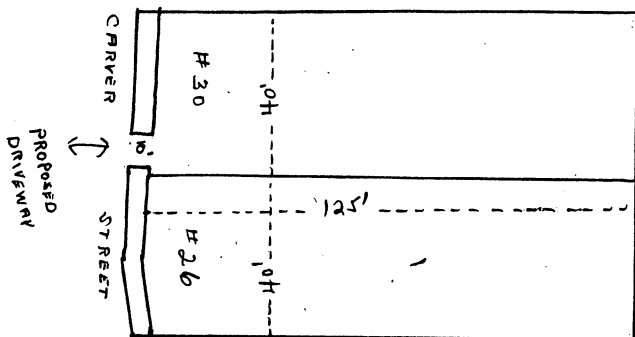

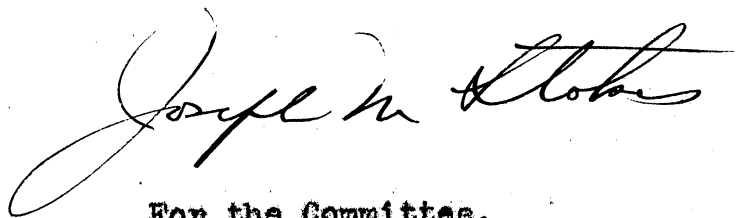
