- WHEREAS: It has come to the attention of this City Council that a career City employee, Gilbert Silvestre, will soon retire from his position as an Inspector in the Department of Inspectional Services, completing sixteen years of service; and
- WHEREAS: Gil served his country well during World War II as a member of the United States Marine Corps from 1946 to 1949 and again during the Korean Conflict as a member of the United States Air Force; and
- WHEREAS: Gil first began his employment with the City in 1966 as an Investigator with the Veteran's Benefits Department, remaining in that assignment for several years prior to transferring to Middlesex County where he was employed until 1973 and on July 19, 1974 was appointed as a Fire Alarm Operator, serving in that capacity until October 21, 1981 at which time he was transferred to the Inspectional Services Department, the position from which he will retire; and
- WHEREAS: Inspector Silvestre will be missed by his friends and colleagues as he enters a new phase of his life, one which will allow him more time to be involved in recreational and family activities; now therefore be it
- RESOLVED: That this City Council go on record extending its sincere congratulations and appreciation to Inspector Gilbert Silvestre for his long and faithful service to the City of Cambridge; and be it further
- RESOLVED: That the City Clerk be and hereby is requested to forward a suitably engrossed copy of this resolution to Gil on behalf of the entire City Council.

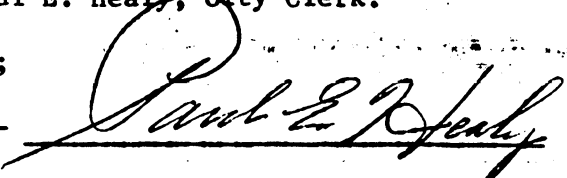
