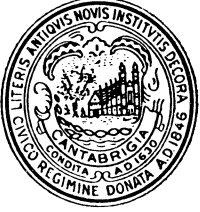


Dear Mr. Corcoran:


To the Honorable, the City Council:
