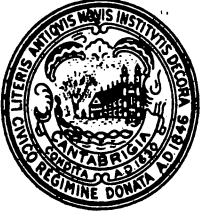

To the Honorable, the City Council:

Listed below are those supplemental budget requests that were received by my office. After reviewing these requests with the budget office, I have decided against recommending any of them. The only additional budget requests that I have recommended are those that were forwarded to the Finance Committee of the City Council at the last budget hearing. The approved requests are: \$25,000 to Public Works Other Ordinary Maintenance for the renovation of the City Council Chambers; \$8,500 to Rent Control Salaries and Wages to restore the legal counsel to part time; \$36,000 to Elderly Services to return the E.A.T. program to its current year service level and the transfer of \$21,000 from Community Schools Salaries and Wages to Community Schools Other Ordinary Maintenance.


