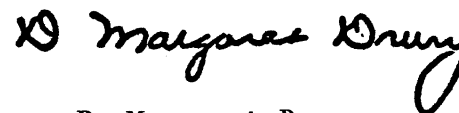

To The Honorable, The City Council:

I am hereby requesting an appropriation of \$838.64 in the Department of Human Service Programs' Planning and Development Division Grant Fund Salary and Wages Account. The Massachusetts Housing and Shelter Alliance has awarded the Department of Human Services these funds to cover a salary increase for the housing caseworker. The Massachusetts Department of Administration and Finance conducted a survey seeking information from its contractors on direct service employees who were making under \$30,000.00. The housing caseworker was in that category. As a result, MHSA has awarded these funds in order to increase the housing caseworker salary to \$30,000.00.
