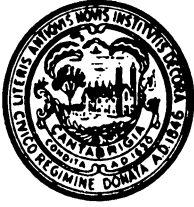

To The Honorable, The City Council:

I am hereby requesting the appropriation of \$22,727.00 in the Grant Fund of the Department of Human Services Salary and Wages Account (\$21,164.00), the Other Ordinary Maintenance Account (\$1,459.00) and the Travel and Training Account (\$104.00) from the Massachusetts Department of Education for Adult Education. These funds will be used by the Community Learning Center to provide an afternoon computer-based class and slots in the existing program for homeless adults.
