ORDERED:

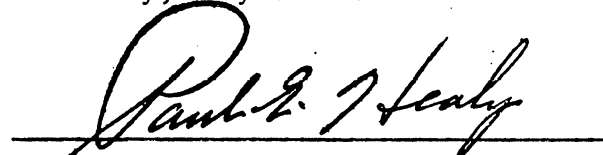
