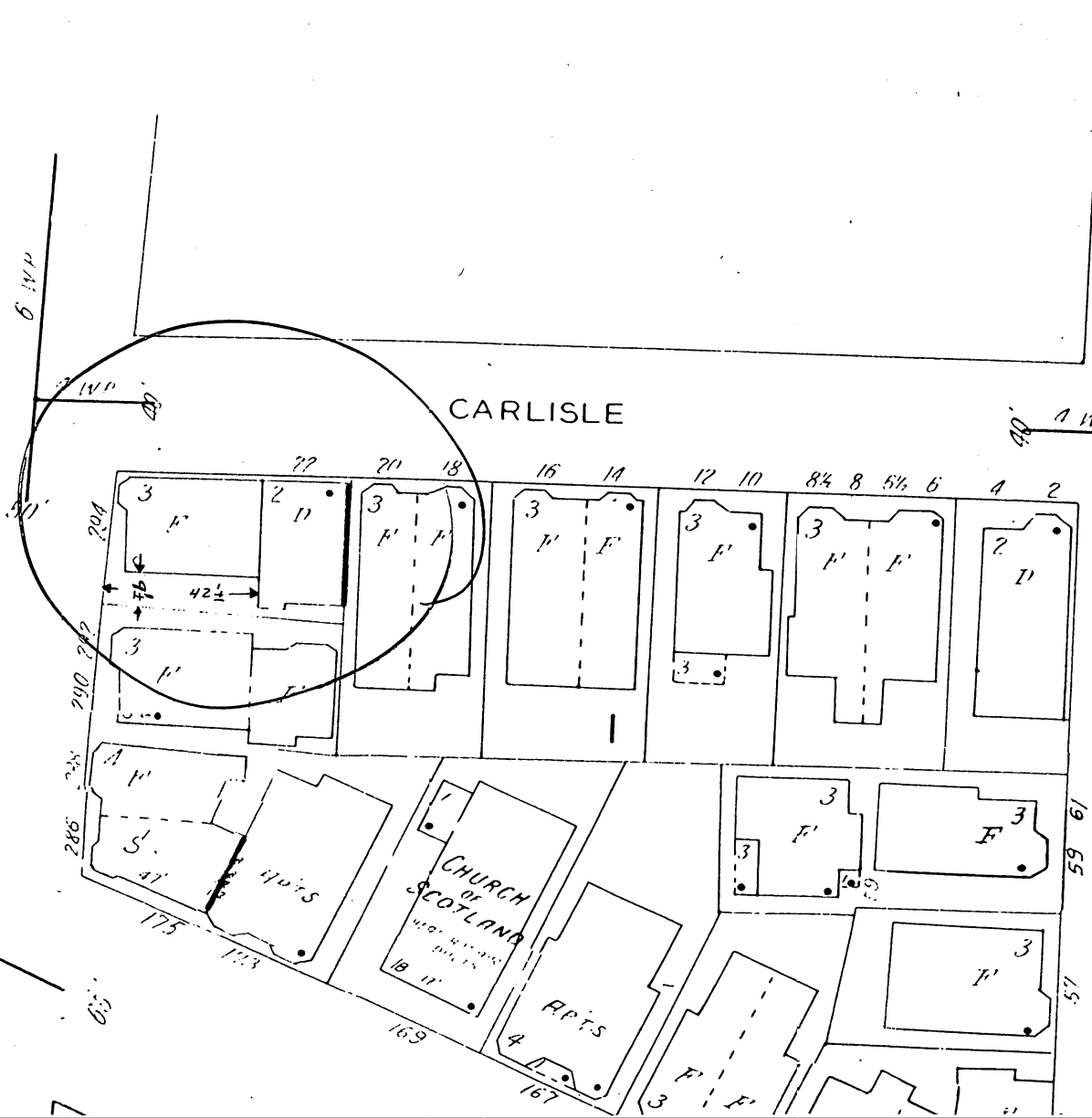
Subject Driveway at 294 Prospect Street
