AN ORDINANCE

In amendment to an Ordinance entitled: "The General Ordinances of the City of Cambridge" as revised in 1972 and now designated as "The Code of the City of Cambridge".

Be it ordained by the City Council of the City of Cambridge as follows:

Article XXII, entitled: "Officers Generally", Section 2-191, List of Salaries in General is hereby amended by striking out said Section 2-191 and substituting in place thereof the following new section:-
