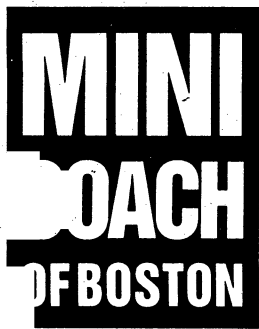

Mini Coach of Boston respectfully submits the following information in order to obtain a Jitney License from the City of Cambridge to provide shuttle service to the Cambridgeside Galleria, Cambridgeside Place, Cambridge, MA.

- (1) Mini Coach of Boston will operate one late model 22 passenger mini coach with handicap accessibility. The vehicle will be clearly marked with the Cambridgeside Galleria logo.

- (2) The hours of operation are as follows:

9:00 A.M. to 10:30 P.M.
11:00 A.M. to 8:00 P.M.

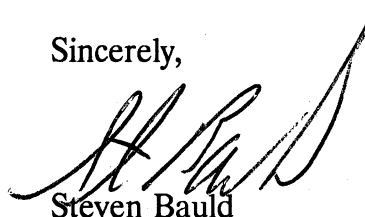
During these hours the vehicle will make approximately 4 runs per hour.

The Traffic and Transportation Committee conducted a public hearing on Tuesday, September 25, 1990 beginning at 6:10 p. m. in the Sullivan Chamber, City Hall, Cambridge, MA.

Members present were: Councillor Sheila Russell, Councillor William Walsh, Councillor Walter Sullivan, Councillor Timothy Toomey, Councillor Jonathan Myers and City Clerk Joseph E. Connarton.

The purpose of the hearing was to review and take testimony relative to the petition of Mini Coach of Boston for a jitney license to provide for a shuttle service over certain streets and ways in the City of Cambridge.

Councillor Russell, Chair of the Committee, opened the hearing and requested the petitioner to come forward and outline the proposal.

At this time the Committee heard from David Stein, representing the New England Development Corporation, 1 Wells Avenue, Newton. Mr. Stein indicated to the committee that his company was the developer of the CambridgeSide Galleria and stated that the Galleria was built in accordance with guidelines outlined in the Master Plan as published by the City of Cambridge dated May, 1978. Furthermore, he informed the committee that during discussions with the East Cambridge Planning Team and the East Cambridge Stabilization Committee relative to the overall project the neighborhood expressed concern regarding increased traffic and parking problems within the neighborhood. It was due to this concern that the New England Development Corporation attempted to mitigate the traffic problem, consequently the idea of a shuttle bus service was conceived and received the strong support and endorsement of the neighborhood associations.

The petition before the committee this evening, he said, was that of a shuttle bus service entitled "Mini Coach of Boston" which has contracted with the CambridgeSide Galleria for the sole purpose of providing a shuttle bus service.

Mr. Stein outlined to the committee the petition as originally submitted to the City Council on September 10, 1990 which requested the use of one-22 passenger mini coach with handicapped accessibility operating Monday thru Saturday between the hours of 9:00 a. m. to 10:30 p. m. and on Sundays between the hours of 11:00 a. m. and 8:00 p. m., a copy of the petition is attached herein and made part of the record. Mr. Stein further stated that although the original petition which is currently before the committee requested the operation of only one mini coach the demand has required the utilization of a second vehicle; therefore he requested to amend the petition to allow for the operation of two-24 passenger mini vans as opposed to one-22 passenger mini van.

Councillor Russell questioned if any member had opposition to the amendment as offered.

No member of the committee voiced opposition and it was voted that the petition be amended.

Councillor Russell further questioned whether or not neighborhood passenger pick ups by the Mini Coach was currently under active consideration.

Mr. Stein responded in the negative and stated he did not anticipate this would happen in the near or distant future.

The Committee then heard from Lauren Preston, Deputy Director of Traffic and Parking, who indicated to the committee that the department has reviewed the route and operation of the shuttle bus service and recommended approval by the committee.

A written approval will be forthcoming from the Department of Traffic and Parking.

The committee heard from Frank Anastasio, Hackney Investigator for the

Cambridge License Commission, who provided a written report from the Chair of the Cambridge Taxicab Advisory Committee indicating that those members present voted unanimous to recommend the approval of the jitney application provided however that the design of the south side of CambridgeSide Place be sufficient to park two taxicabs and two-24 passenger shuttle mini vans.

The committee heard from Joseph Russell, a Cambridge taxi owner, who informed the committee that the original membership of the CTAC had somehow been restructured by the Chair of the License Commission. He further stated that although he, as a taxi owner, did not personally oppose the petition before the committee, he urged the committee to conduct a public hearing relative to the operation of the License Commission and CTAC.

The committee then heard from Arthur Santoro, owner and operator of Campus Cab, who voiced his agreement with the previous speaker and indicated to the committee that the taxi industry was being threatened by the actions of the License Commission and requested the committee to look into these charges.

The committee heard from Carol Youngclause, owner of the Yellow Cab medallion #1904, who stated that she too was no longer a member of the CATC and urged the Committee on Traffic and Transportation look very carefully into the restructuring of CTAC. She further indicated that she reluctantly was in favor of the petition of Mini Coach of Boston.

The committee heard from Bill Cavellini, Operator of an Ambassador-Brattle Cab, who stated that CTAC met and he was only one of two representatives of the industry. He further stated that he had concern with the petition because they had violated their temporary permit by utilizing more vans than approved and was operating at more frequent intervals than were permitted.

Left onto Otis Street, right onto First Street, left onto CambridgeSide Place and stop. Start again from beginning; and be it further

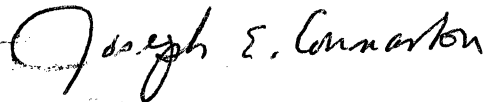

Councillor Sullivan then moved that the Director of Traffic and Parking be requested to restore the cab stand formally located at the Lechmere Station; said stand to be replaced at its former location or a suitable replacement location.

The hearing was adjourned at 6:33 p. m. on motion of the Chair.
