I am hereby requesting the appropriation of \$268,585.00 in the Grant Fund of the Department of Human Services Salary and Wages Account (\$231,303.00), Other Ordinary Maintenance Account (\$36,952.00) and Travel and Training Account (\$330.00) from the Massachusetts Department of Education.
