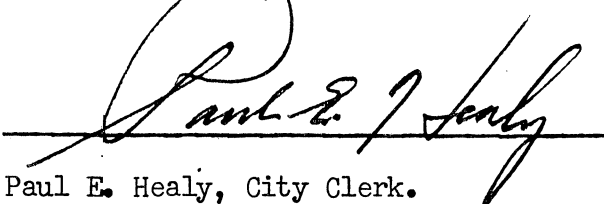
I am writing in response to the request of the Cambridge City Council to express to you their concern at any further increase in the rates and charges of the New England Telephone and Telegraph Company.

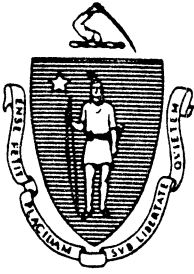

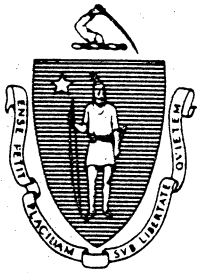
