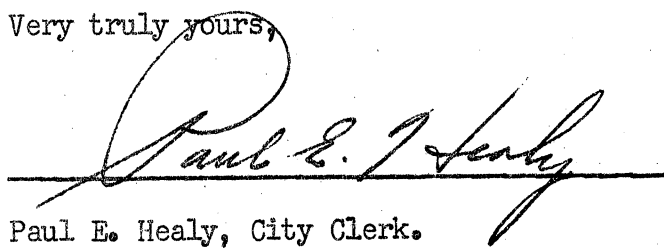
Dear Neighborhood Representative:

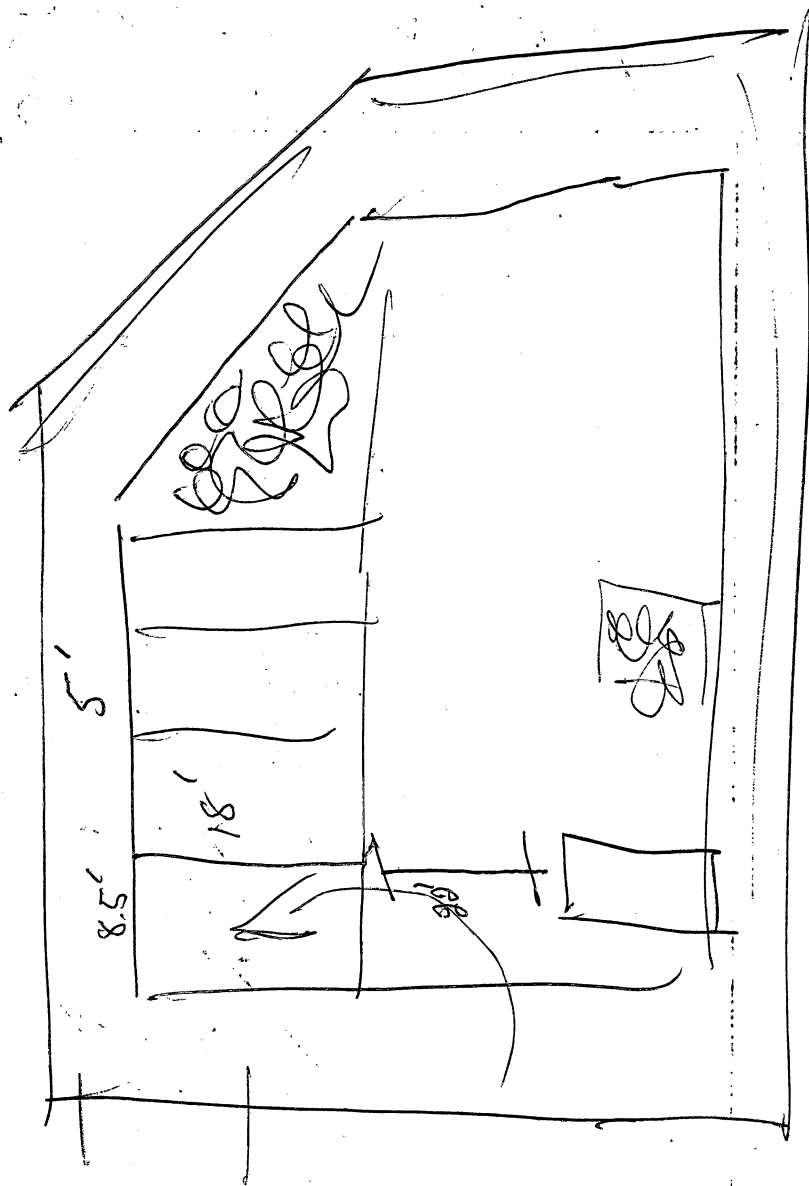
