At the center I have worked on the preparation of an SSI Advocates Manual for Massachusetts; training programs for lawyers and laypersons throughout the state; representing individuals in hearings and appeals; and federal and state litigation aimed at improving the SSI program. 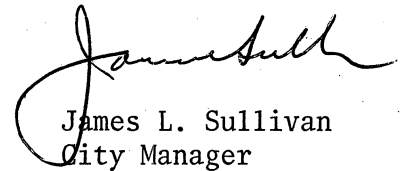
