Pursuant to the provisions of Chapter 28, Regulation of Traffic - Article III, Section 4, Location of Bus stops, trackless trolley stops, taxicab stands and service zones, The Metropolitan Transit Authority is hereby granted permission to move the ~~trackless~~ ~~to~~ Bus Stop now located on Massachusetts Avenue at Newport Road, to Forest Street, near the Traffic Lights at Linnaean Street Outbound only, extending 60 feet, with permission to erect stanchions with signs attached, reading, "Trackless Trolley and Bus Stop-No Parking".

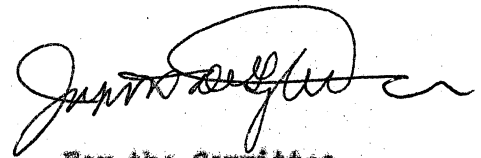
