ORDERED:

That, in accordance with the provisions of an ordinance relative to placing and maintaining signs, the Commissioner of Public Works be and hereby is authorized to grant a permit to St. Peter's Episcopal Church for the erection of a flagpole at the premises numbered 838 Massachusetts Avenue, Cambridge, Massachusetts.

Provided that, before erecting the above named flagpole the petitioner shall obtain a permit from the Inspectional Services Department and file with the City Clerk a satisfactory bond in the sum of Two Thousand (\$2,000.00) Dollars, conditioned to save harmless the City of Cambridge from all claims for damages arising from the installation, maintenance and use of said flagpole.

The undersigned respectfully prays that St. Peter's Episcopal Church be granted permit to erect a flag pole of the following specifications in front of premises 838 Mass. Ave.

Type: Ten-foot flag pole of fiberglass construction to fly 4' X 6' flag
(State whether Electric or otherwise and material used in construction)

Reading matter to go on sign: NO WRITTEN TEXT -- EPISCOPAL CHURCH FLAG

Size: Fiberglass pole is ten feet long, to which is added a 5-inch ball.

Weight: The fiberglass pole and ball weigh less than 23 pounds.

How Erected: A: at 45° angle, 6½ feet B: 12 feet
