2. The purposes for which the corporation is formed are as follows:

- 1) To operate a school for non-profit, designed to promote and advance the educational development of children; and in furtherance to provide for and furnish instruction, supervision and guidance.
- 2) To do any and all things directly or indirectly related to any of the foregoing purposes or to any activity in which the corporation may engage in accordance with Chapter 180 of the General Laws of the Commonwealth of Massachusetts.
- 3) To do any and all other lawful things which may be permitted under Section 501 C (3) of the Internal Revenue Code of 1954 as now in force or hereafter amended, or under any comparable provisions of the Federal Tax Laws from time to time in effect conversely, any purpose or activity which is prohibited exempt organization under said section shall be deemed to be invalid and unauthorized; and in addition, only such activities as shall be permitted by Chapter 180 of the General Laws of Massachusetts shall be authorized.

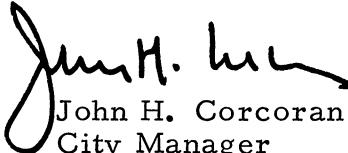
