



To the Honorable, the City Council:

Attached is a request from the Public Library to transfer \$8,000.00 from their Salary and Wages account to their Travel and Training account \$1,000, and the Other Ordinary Maintenance account \$7,000. This transfer is needed for the following reasons: \$1,000 for three staff members to ALA Conference; \$2,000 for increase in book materials; \$1,000 to cover material and office supplies; and \$4,000 to pay for oil burner replacements at the Field Branch and Mount Auburn Branch Libraries, an air conditioning unit for computer center, and door renovation at the Field Branch Library.
