WHEREAS: The necessity of compliance with the state sanitary code and safety laws is something that has to be dealt with by the City Council; and

WHEREAS: The City Inspectional Services is already over burdened with routine daily calls for sanitary and building code violations; and

WHEREAS: Historically, the Fire Department has provided routine inspections in the area of Fire Safety; and

WHEREAS: The City Manager will soon be submitting the draft of a report on how a city-wide building inspection would be implemented; and

WHEREAS: Any implementation of this city-wide program would have to be done very carefully, so that it has the least impact on the least amount of citizens; now, therefore be it

RESOLVED: That the City Manager be and is hereby ordered to submit the report to the City Council as soon as possible, with recommendations from the Inspectional Services Department, as to what part they will play in this City-Wide program, as to the feasibility of the Fire Department assisting in this program, the Human Services Department as to how they would assist persons who might be affected by this program, from the Housing Authority as to the part they would play in finding emergency housing if necessary, from the Rent Control Board to explain how this code enforcement inspection would affect those units on the rent control rolls, and lastly what part the city could play in assisting land-lords who would be hard pressed to make the necessary improvements.
