ORDERED:

That, in accordance with the provisions of an ordinance relative to placing and maintaining signs, the Commissioner of Public Works be and hereby is authorized to grant a permit to A. Peter Smargon, Executive Director, Cambridge YMCA, for the erection of a banner across Massachusetts Avenue for the period of September 22, 1978 through September 30, 1978.

Provided that, before erecting the above named banner, the petitioner shall obtain a permit from the Building Department and file with the City Clerk a satisfactory bond in the sum of Two Thousand Dollars (\$2,000.00) conditioned to save harmless the City of Cambridge from all claims for damages arising from the construction, maintenance and use of said banner.
