The following is a request for a transfer of appropriation in the 1972 License Commission Budget:


From: C-9, Office Equipment, the sum of \$112.16

To: C-7, Furniture and Fittings.

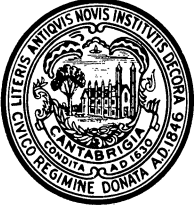
