IN CITY COUNCIL

November 2, 1992

ORDERED: That, in accordance with the provisions of an ordinance relative to placing and maintaining signs, the Commissioner of Public Works be and hereby is authorized to grant a permit to Elegant Tailor and Cleaners for the erection of a canopy at the premises numbered 1687 and 1689 Massachusetts Avenue, Cambridge, Massachusetts.

Provided that, before erecting the above named canopy, the petitioner shall obtain a permit from the Inspectional Services Department and file with the City Clerk a satisfactory bond in the sum of Two Thousand (\$2,000.) Dollars, conditioned to save harmless the City of Cambridge from all claims for damages arising from the construction, maintenance and use of said canopy.

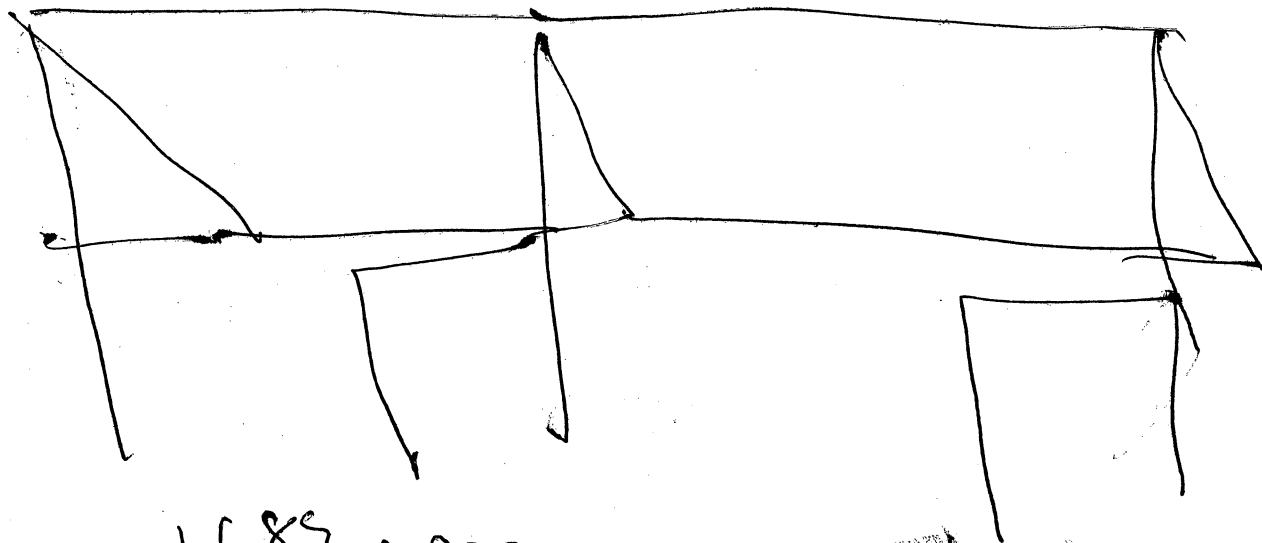
