I am hereby requesting an appropriation of \$89,000.00 to the Grant Fund Community Development Department Salary & Wages Account (\$82,000), Other Ordinary Maintenance Account (\$6,000) and Travel & Training Account (\$1,000). The funds will support an 18-month Central Artery coordinator staff position to monitor Central Artery construction, coordinate City departments, and serve as liaison between the City, the public, and the Central Artery/Tunnel Project staff. Also the funds will provide for the purchase of a personal computer, furniture, supplies and training for the staff person.
