For the seventh consecutive year, we are joyously planning for this May's DanceMonth celebration.

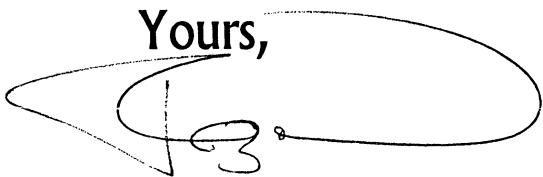
Could you please oversee the bureaucratic (office-based?) end of hanging our banner over Mass Ave?

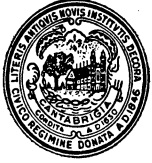
