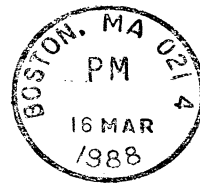

RESOLVE RELATIVE TO FRESH POND

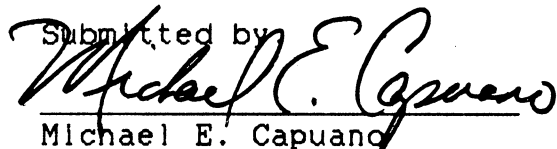
WHEREAS, the citizens of Somerville have always extended their hands in friendship to their neighboring communities, and
