On June 21, 1988 around 10:30 a.m., our car was ticketed and towed from in front of our residence on Hammond Street. That was a street cleaning day, and we had moved the car early in the morning, departing to run several errands. When we returned, around 9:30 a.m., the street sweeper had very clearly already been by, so we parked on that side of the road. Sometime during the next hour a traffic officer tagged the car and ordered it to be towed.

We do not dispute the need to keep our city's streets clean, and we always scrupulously endeavor to have our car moved on sweeping days. However, to have a car ticketed and towed after the street sweeper has already gone by can be explained only as enforcement for its own sake. It hardly seems that either the city's coffers or the pockets of our faithful local towing services are so badly in need of enriching to justify this sort of harrasment of our citizenry.

Therefore, I do not intend to pay the above-referenced ticket, and I hereby request that the City of Cambridge reimburse me for the \$50.00 which I incurred to retrieve my car (I cycled over to avoid cab fare, and I will not charge you for my inconvenience). Thank you for your prompt attention to this matter.
