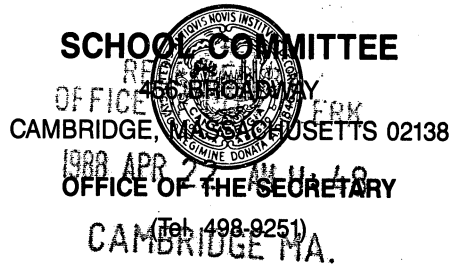

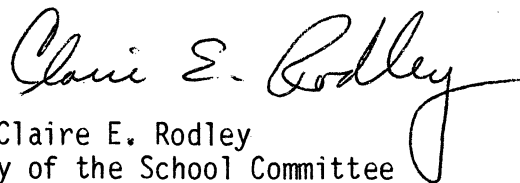
Dear Councillors:
