

# **Rev. Joseph Fusoni**

**St. John's Church pastor; at 55**

A funeral Mass for Rev. Joseph A. Fusoni, pastor of St. John the Evangelist Roman Catholic Church in North Cambridge since 1985, will be said tomorrow at 10 a.m. in St. John's. Father Fusoni died of lung cancer Sunday in the Dana-Farber Cancer Institute. He was 55.

Father Fusoni was born in Milton and ordained in 1960 after studying at St. John's Seminary in Brighton. His earlier assignments were as assistant or associate pastor at St. Mary, Ayer; St. Jerome, North Weymouth; St. Mary, Dedham; Our Lady of Lourdes, Revere; St. Mary, Brookline; St. Therese, Everett; St. Cecilia, Boston; St. Anthony, Revere; Our Lady of Grace, Chelsea; St. Thomas of Villanova, Wilmington, and St. Joseph, Wakefield.

Father Fusoni leaves his mother, Anna Fusoni of Milton, and three sisters, Ann F. Palmer and Eleanor M. Fusoni of Milton and Mary Fusoni of Arlington.
