SIGN ON 1878 MASS. AVE.

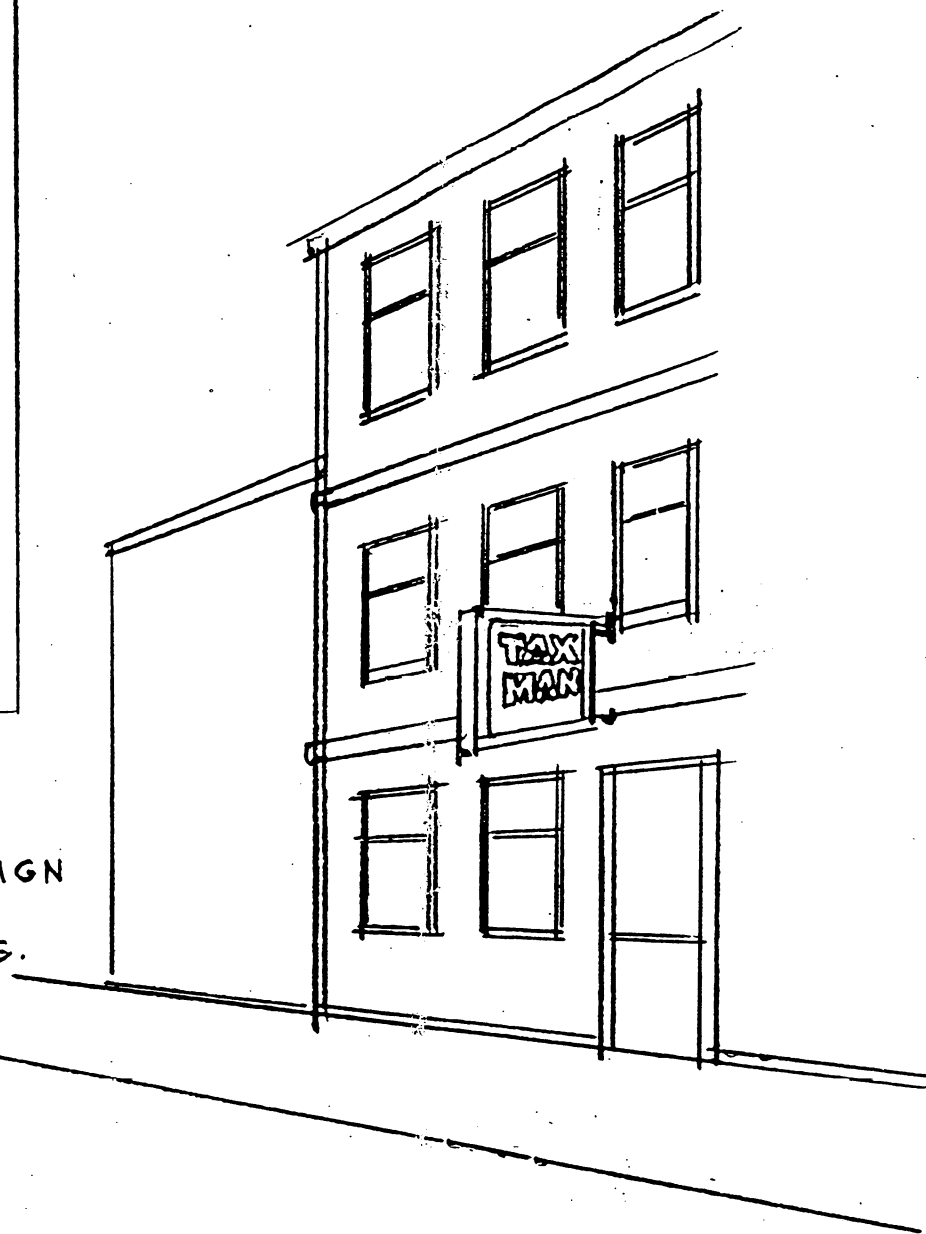
