

KNOW ALL MEN BY THESE PRESENTS: That the ROYAL GLOBE INSURANCE COMPANY, Corporation organized and existing by virtue of the Laws of the State of ILLINOIS does hereby nominate, constitute and appoint HUGH M. CHAPIN or GEORGE M. DALEY or DIANNE M. MORRISSEY

of CAMBRIDGE, in the state of MASSACHUSETTS its true and lawful attorney(s)-in-fact to make, execute, attest, seal and deliver for and on its behalf, as surety, and as its act and deed, where required, any and all bonds, undertakings, recognizances and written obligations in the nature thereof, the penal sum of no one of which is in any event to exceed FIFTY THOUSAND (\$ 50,000.) Dollars.

Such bonds and undertakings, when duly executed by the aforesaid Attorney(s)-in-fact shall be binding upon the said Company as fully and to the same extent as if such bonds and undertakings were signed by the President and Secretary of the Company and sealed with its corporate seal.


