### PROGRESS REPORT OF THE MAYOR'S BLUE RIBBON COMMITTEE ON TRAFFIC MITIGATION AND PARKING SUPPLY RESTRICTIONS

On Thursday evening, June 21, 1990, the Members of the Mayor's Blue Ribbon Committee met for the first time. (membership list attached.)


The Committee agreed to forward a request to the City Council asking the Council to place any action on the proposed Traffic Mitigation Zoning Petition, which is currently before them on the table, so that the Blue Ribbon Committee can have adequate time to study and report recommendations relative to this most important, complex issue.

This committee proposes that more time be given to discuss issues such as the proper time frame for the Committee to do its work, the composition of the Committee, availability of resources to hire technical consultants, and to properly define the Committee's mission.

Given the complexity and degree of importance this petition has for the City's future, the Committee indicated that by July 30, 1990, they would be able to better outline its goals and begin to focus on a schedule. It was agreed that it would be difficult and somewhat premature to try to meet the time frames as described in Councillor Walsh's order and will formulate a more realistic time frame.

The Committee will meet again on Wednesday, July 11, 1990 at 7:00 p.m..
