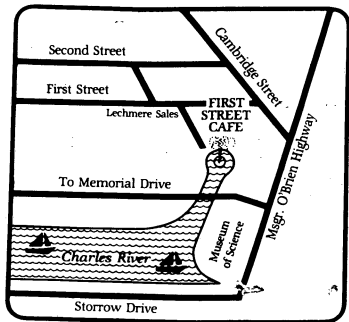

City of Cambridge:

The undersigned respectfully pray

The Company--Cambridge Restaurant Associates Inc.--requests permission to operate a Sidewalk Cafe at its business location, One Canal Park, in the area along the canal side of the building at One Canal Park. The space is bordered by handicap ramps, one at the Thorndike Way end of One Canal Park, the other at the Otis Way end.

The period of operation would be concurrent with that of the Company's restaurant and Take Out Store. The period of use would be April to October, weather permitting.

A Sidewalk Cafe is in keeping with the intended use of the park area and would be in harmony with the public use of the new park. The Cafe would service the many new businesses in the area as well as local residences, the courthouse, and the new condominium development.

The specifics of our request are as follows:

- A. The approximate number of seats would be 175.
- B. The hours of operation would be 11:30 am to 12 midnight.
- C. The size of the space would be 18 feet from the side of One Canal Park extending to the new handicap ramps.
- D. The Cafe would be in operation seven days of the week.
