THIS ACTION IS BEING TAKEN IN RESPONSE TO THE BUDGET REVISION RECENTLY SUBMITTED TO THE CONGRESS BY THE ADMINISTRATION. THE REVISION PROVIDES

FOR THE DEFERRAL OF \$203 MILLION IN TITLE VI BUDGET AUTHORITY AND A NATIONAL END-OF-FISCAL YEAR 1980 ENROLLMENT LEVEL UNDER TITLE VI OF 149,000. THE DEFERRAL ACTION WAS TAKEN IN ACCORDANCE WITH 31 USC 1403

OF THE IMPOUNDMENT CONTROL ACT OF 1974.

THESE INSTRUCTIONS SHOULD BE TREATED AS A UNILATERAL MODIFICATION. A SIGNED MODIFICATION WILL FOLLOW. NO MODIFICATION TO EXISTING PLANS AND NO DEOBLIGATION OF FUNDS WILL BE REQUIRED AT THIS TIME AS A RESULT

OF THIS HIRING FREEZE.

PLEASE NOTIFY YOUR CETA PROGRAM DIRECTOR OF THIS INFORMATION IMMEDIATELY.

AS YOU KNOW, A PROPOSED REVISION TO THE FISCAL YEAR 1980 U.S. DEPARTMENT OF LABOR BUDGET HAS BEEN SUBMITTED TO CONGRESS WHICH CALLS FOR ENDING FY 1980 AT A CETA NATIONAL TITLE VI ENROLLMENT LEVEL OF 149,000. IN ADDITION, THERE IS A PROPOSAL TO DEFER \$203 MILLION IN FY

80 TITLE VI EXPENDITURES. THEREFORE, EFFECTIVE APRIL 25, 1980 YOU SHALL

NOT ENROLL ANY NEW PARTICIPANTS OR REFILL ANY VACANCIES IN PROGRAMS FUNDED UNDER TITLE VI OF THE COMPREHENSIVE EMPLOYMENT AND TRAINING ACT

(CETA). THIS PROHIBITION AGAINST ENROLLING PARTICIPANTS IN TITLE VI PROGRAMS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE.

THIS APPLIES TO ALL ACTIONS IN THE PIPELINE EXCEPT IN CASES WHERE IT CAN BE DOCUMENTED THAT AN INDIVIDUAL HAS BEEN FORMALLY HIRED BUT HAS NOT YET REPORTED FOR DUTY. PERSONS THAT ARE HIRED BUT HAD NOT REPORTED

PRIOR TO APRIL 25 MAY BE ENROLLED IF THE FOLLOWING CONDITIONS HAVE BEEN MET:

A. SUCH INDIVIDUALS HAVE BEEN DECLARED ELIGIBLE BY THE SPONSOR'S INTAKE SYSTEM;

B. SUCH INDIVIDUALS HAVE BEEN INTERVIEWED AND SELECTED PRIOR TO APRIL 25, 1980;

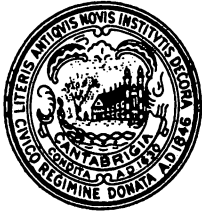
C. A STARTING DATE MUST HAVE BEEN DETERMINED, AND THE SPONSOR MUST HAVE BEEN NOTIFIED OF THE SELECTION BY THE EMPLOYING AGENCY PRIOR TO APRIL 25, 1980;

D. THE CETA INTAKE FORM MUST HAVE BEEN COMPLETED TO ACTUALLY PHYSICALLY

ENROLL SUCH INDIVIDUALS AS CETA PARTICIPANTS. WHERE THIS LAST STEP WAS NOT 100 PERCENT COMPLETED BY APRIL 24, 1980, A REASONABLE PERIOD

OF TIME (UP TO MAY 2, 1980) SHALL BE PERMITTED FOR THE COMPLETION

ALL REQUIRED PAPERWORK (SUCH AS PAYROLL TRANSACTIONS). HOWEVER, AS


