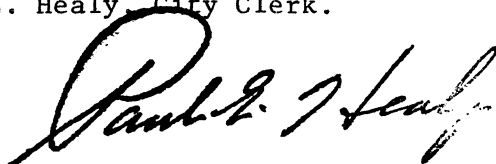

Attached please find for your review and action an order requesting the acceptance and appropriation of a grant in the amount of \$6,466.20 from the State Executive Office of Communities and Development to the Grant Fund of the Department of Human Service Programs Other Ordinary Maintenance account.

In November, \$2,528,242 was appropriated for FY85 Fuel Assistance based on the projected availability of Federal funding for the program. However, actual receipts have exceeded the appropriation by \$6,466.20.
