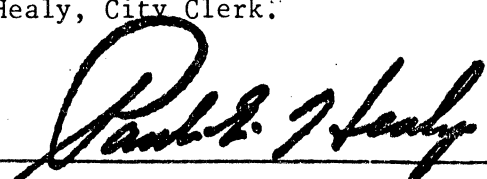

Location of proposed driveway 33 Pemberton Street

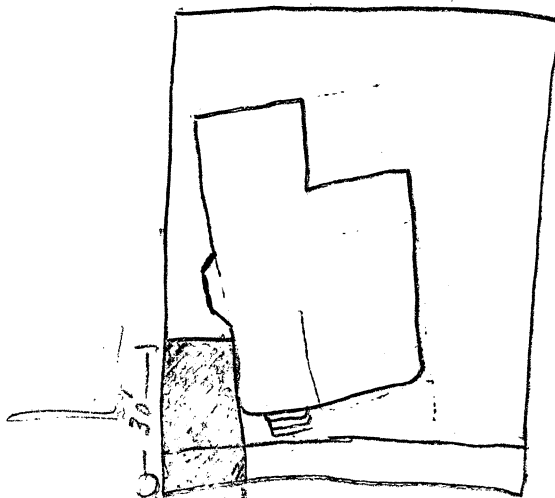
