


To the Honorable, the City Council:

I am pleased to inform the City Council that the Cambridge Arts Council has recently been awarded a grant of \$15,000 from the National Endowment for the Arts for Community Arts Facilitation.

This grant will be used to develop six cultural forums within Cambridge; including the elderly, public housing residents, neighborhood groups, churches, local performing groups and school personnel. The Arts Council plans on using half of this grant, \$7,500.00, in the current fiscal year and half in 1977-78. Their budget request for 1977-78 reflects these plans, therefore we are asking that only \$7,500.00 be appropriated at this time.

Passage of the attached orders is recommended.
