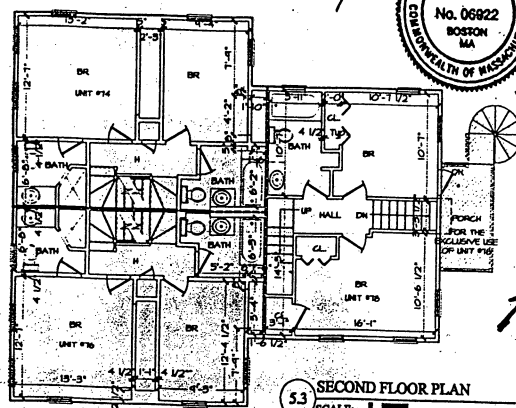

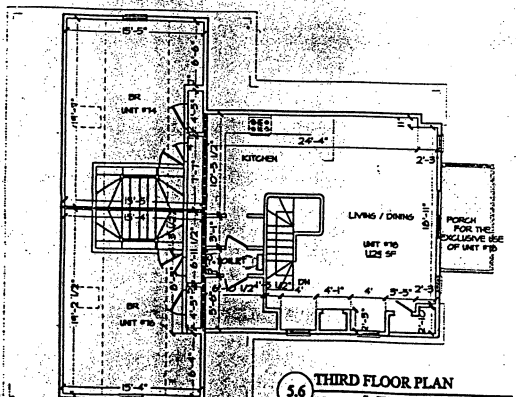

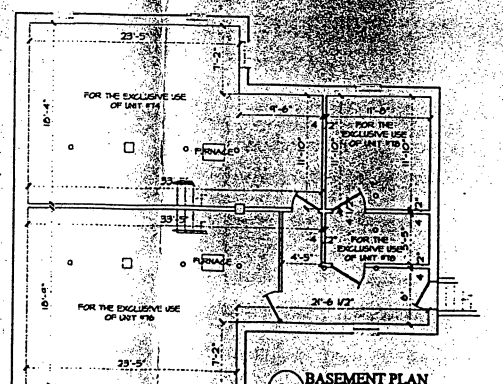
5.3 SECOND FLOOR PLAN

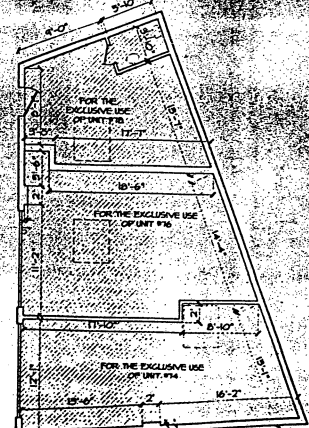
2.3 FIRST FLOOR PLAN

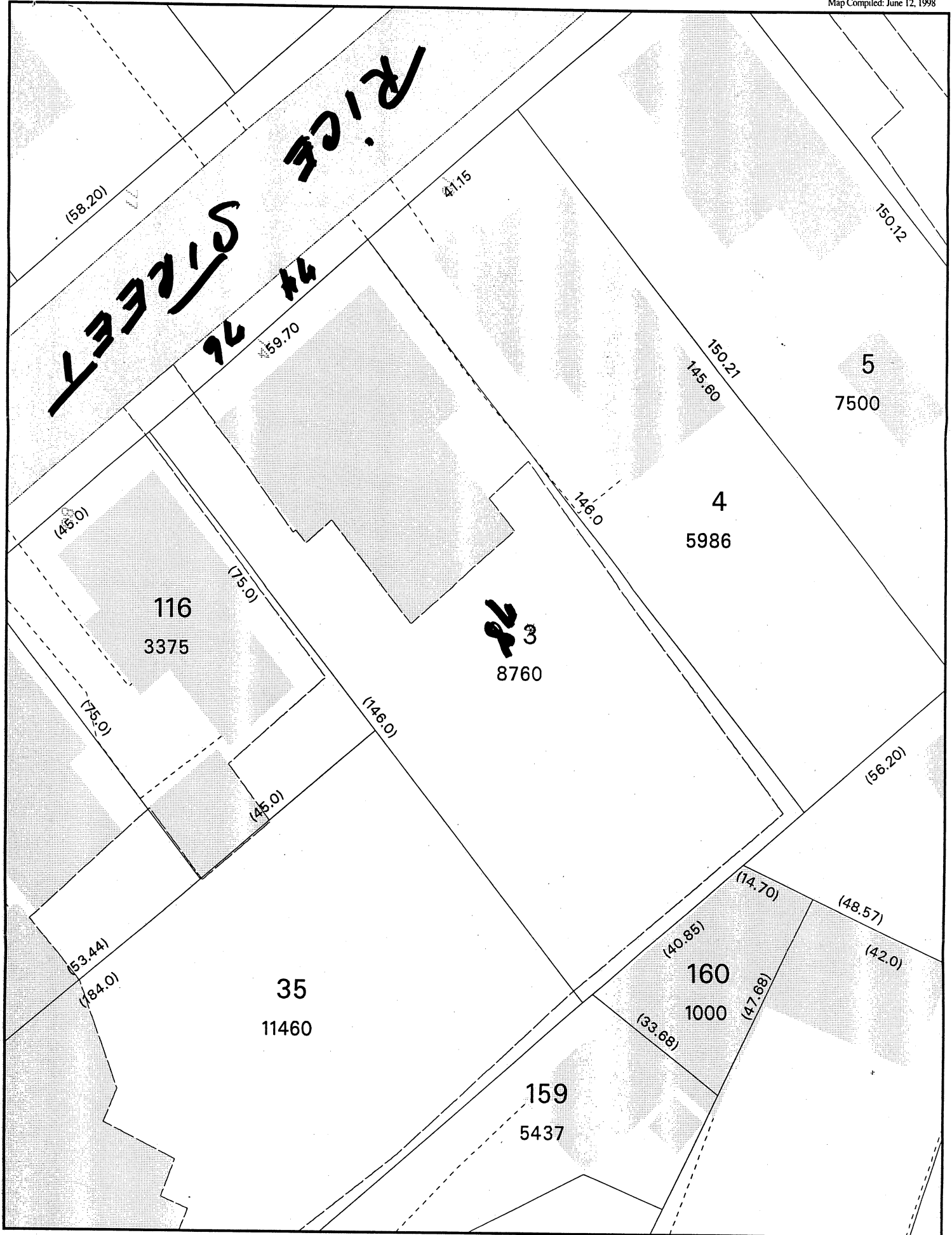
5.6 THIRD FLOOR PLAN

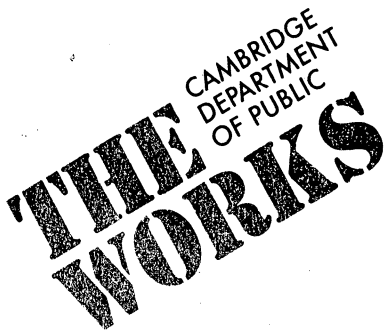
