This past year, the Police Department negotiated with the Patrol Officers Association and reached agreement to staff four (4) motorcycle enforcement officers on the evening shift on a Monday through Friday basis. Coupled with traffic enforcement staffing during the day shift, regular enforcement of all truck restrictions, as well as all moving violations, will be adhered to. A listing of "hot spots" (see enclosed) to be monitored is updated monthly and issued to the Patrol Sections and to the Selective Enforcement Unit.

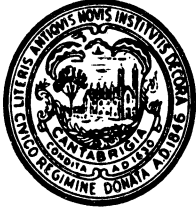
