RESOLVED: That this City Council go on record extending Happy 97th Birthday wishes to Geneva Mitchell, a special Cantabrigian; and be it further

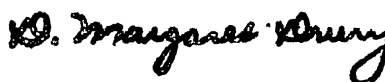
