

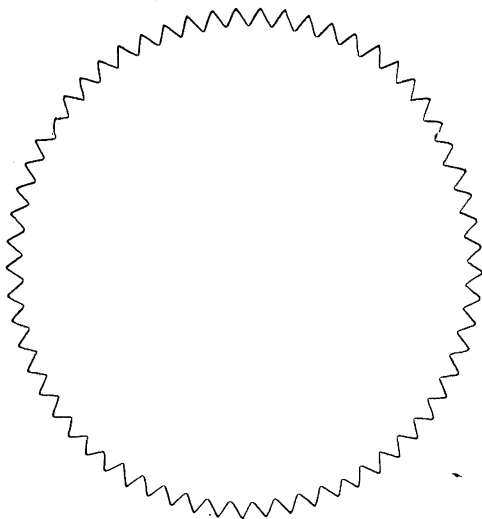

THE COMMONWEALTH OF MASSACHUSETTS

In the Year One Thousand Nine Hundred and Sixty-three

RESOLVE PROVIDING FOR AN INVESTIGATION AND STUDY BY THE MASS TRANSPORTATION COMMISSION RELATIVE TO AUTHORIZING THE METROPOLITAN DISTRICT COMMISSION TO CONVEY A CERTAIN PARCEL OF LAND LOCATED IN CAMBRIDGE, ARLINGTON AND BELMONT TO THE METROPOLITAN TRANSIT AUTHORITY.

RESOLVED, That the mass transportation commission is hereby authorized and directed to make an investigation and study of the subject matter of current house document numbered 1511, relative to further authorizing the metropolitan district commission to convey a certain parcel of land located in Cambridge, Arlington and Belmont to the Metropolitan Transit Authority. Said commission shall report to the general court the results of its investigation and study, and its recommendations, if any, together with drafts of legislation necessary to carry its recommendations into effect, by filing the same with the clerk of the house of representatives on or before the last Wednesday of January, nineteen hundred and sixty-four.

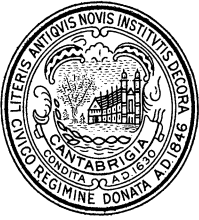
