ORDERED:

That, in accordance with the provisions of an ordinance relative to placing and maintaining signs, the Commissioner of Public Works be and hereby is authorized to grant a permit to The First Holiness Church, Inc. for the erection of a banner across Massachusetts Avenue, Central Square, for the period of July 27, 1979 through August 6, 1979.

Provided that, before erecting the above named banner, the petitioner shall obtain a permit from the Building Department and file with the City Clerk a satisfactory bond in the sum of Two Thousand Dollars (\$2,000) conditioned to save harmless the City of Cambridge from all claims for damages arising from the construction, maintenance and use of said banner.

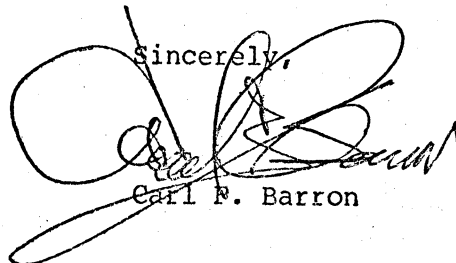
Dear Mr. Haywood:
