To The Honorable, The City Council:

Attached is an order requesting the appropriation of \$274,500.00 in the Grant Fund from the Massachusetts Department of Education to the Human Services Department Salary & Wages Account \$239,418.00, Other Ordinary Maintenance Account \$34,850.00 and Travel & Training Account \$232.00. The Community Learning Center will provide educational services to adults in need of basic skills through the high school level. Programs will include adult basic education, creole literacy, English as a Second Language, and adult secondary education. Educational and vocational counseling and referrals will also be provided for students. The funds will specifically pay for 5 full-time employees, nearly half of the Learning Centers rent, part-time instructors and operating supplies.
