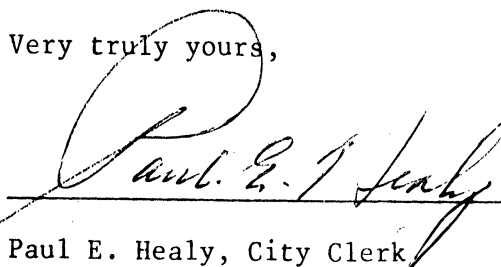
Dear Mr. Goldberg:

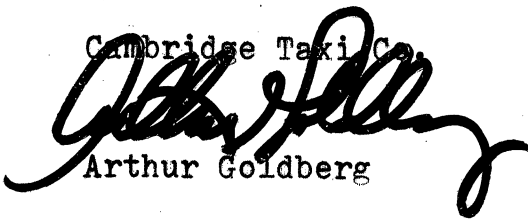

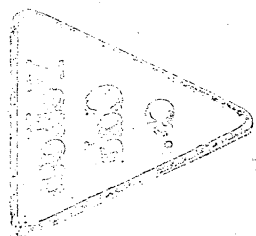
