WHEREAS: The Mayor's Office has received a number of telephone calls and letters containing complaints about the "deplorable condition of the sidewalks and street surface" along Griswold Street; and

WHEREAS: The attached copy of a petition of Owners' signatures underscores the 'crisis' nature of these conditions and compels immediate response thereto; and

WHEREAS: A number of Griswold Street residents are afflicted with various handicaps, and their ability to cope therewith and their rights to safe mobility are aggravated by the hazards which the present conditions of Griswold Street present; now therefore be it

ORDERED: That the City Manager direct the Commissioner of Public Works to examine the "deplorable conditions" on Griswold Street, and, with a determined time framework for initiation and completion of projected repairs, report back to this Council no later than thirty (30) days after acceptance of this Order.
