City Council Calendar Item # 16 of 12/21/92 requested a report detailing the staffing levels and assignments by shift in the Uniform Division for the first half of fiscal year 1993.

On July 1, 1992, the Police Department employed 251 sworn officers. A total of 180 officers (72%) were assigned, in uniform, to the Operations Division. Of this total, 67 officers (37%) were assigned to Day Patrol Section and 113 officers (63%) were assigned to Night Patrol Section.

As of today's date, the Police Department has 228 sworn officers. A total of 162 officers (71%) are assigned, in uniform, to the Operations Division. Of this total, 59 officers (36%) are assigned to Day Patrol Section and 103 officers (64%) are assigned to Night Patrol Section.

Assignments on specific shifts vary and are dependent on a number of factors including staffing levels, calls for service analysis, reported crime, community and neighborhood concerns, etc.

Staffing levels are dependant upon contractual obligations (vacation days, personal days, etc.), scheduled in-service training, absenteeism, and sick time (16.8 days per officer average in 1991).
